

LOCAL WORKFORCE INVESTMENT BOARD CONTACT PERSONS FOR ELIGIBLE TRAINING PROVIDER APPLICATIONS

Eligible Training Providers (ETP) will be certified by one of the seven Local Workforce Investment Boards. Application materials will be submitted to either a Regional or Local Workforce Investment Board (LWIB) through the State Web-Site or by mailing the materials to the contact persons for the Regional or Local Boards identified below. Applications need to be submitted to only one of the Regional or Local Boards to be included on the State List of Certified Eligible Training Providers. Though application materials may be submitted to any of the Regional or Local Workforce Investment Boards, in most cases providers will select the Board nearest their training facility. Notice that the Oregon Workforce Alliance Local Workforce Investment Board (WIB) serves the 23 rural counties that encompass much of the State. Applications for this area may be submitted either to the Region or to the Oregon Workforce Alliance who will consult with the appropriate regional contacts listed below; however, the final Board approval is the responsibility of the Oregon Workforce Alliance Local Workforce Investment Board.
